# Image: Comparison of the comparison

Abstract: The act of the caretaker accused in putting a chilli into the mouth of a two-year-old child thereby causing the child to choke to death is a very serious form of abuse, and any remorse shown for such misdeed cannot per se justify a short sentence of imprisonment. Hence, an 18-month imprisonment sentence so passed by the High Court for the offence under s. 31(1) of the Child Act 2001 is obviously inadequate and should be substituted with imprisonment for a term of 10 years.

**CRIMINAL PROCEDURE**: Sentence - Appeal against sentence - Offence of child abuse - Causing death of child - Plea of guilty - Whether sentence of 18 months imprisonment manifestly inadequate - Causing child to choke to death by putting chilli inside child's mouth - Whether deliberate act - Whether act of showing chilli to child before putting into child's mouth was to create fear - Whether form of abuse - Whether remorse shown by accused justified sentence of 18 months imprisonment - Whether sentence ought to reflect gravity of offence - Whether sentence ought to be substituted - Child Act 2001, s. 31(1)(a)

The respondent had been entrusted with the care of the child ('deceased'), aged two years and seven months. On 13 June 2018, the deceased, who was not well at the material time, was sent to the respondent's house together with his brother. While there, the deceased cried continuously and when the respondent's attempts to stop the deceased from crying failed, the respondent showed a green chilli to the deceased to scare the deceased. When the deceased continued crying, the respondent popped the green chilli into the mouth of the deceased when his mouth was gaped open as he was crying. This caused the deceased to have difficulty to breathe. The respondent tried to give some water but the deceased could not swallow the water and was hence, rushed to the clinic and subsequently to the hospital. The deceased passed away despite the attempts to treat him. The post mortem report showed that the cause of death
